

Dear Chair of Governors

ICT has a unique position within schools today in the drive to raise standards and support learning. After staffing, the provision and sustainability of ICT equipment and services has become the most expensive item on most schools' annual budget. In 2004 the only ring-fenced funding for schools, whether primary or secondary, relates to the provision of ICT equipment and services. Recent ministerial announcements regarding the flexibility to use capital funding for ICT purchases where the school feels appropriate emphasise the contribution that ICT can make to learning. In addition, every school is receiving a fixed sum for the purchase of educational computer software from a government catalogue of curriculum-aligned material (Curriculum Online – COL). Following four years with an emphasis on 'boxes' and 'wires' there is now a coherent move towards encouraging effective ICT usage by all staff and students.

The DfES has commissioned Becta to produce a series of ten six-page guides to be published monthly from mid 2004. Each will also be available on Becta's website [http://www.becta.org.uk/schools/leaders].

Each pamphlet will provide specific information on an aspect of ICT, together with suggested routes that individual governors can follow to find additional help. This first document is focused on you as the Chair of Governors and we hope that you will sign up for the entire series to maintain your personal overview of ICT development. We recommend you distribute further copies to individual members of the governing body or to a particular committee. Evaluating leadership and management implications

Focusing on key strategic issues Stimulating a clear vision both to understand the potential of ICT as an enabler of whole-school improvement and also to realise where ICT is an appropriate solution and where it is not. In many schools ICT has previously been seen as a curriculum subject only, whereas now ICT should be seen as having a much more all-encompassing position within education. Your school may already have an ICT governor who has been supporting the subject ICT. There is now an opportunity and a need to have an e-learning governor with a much broader ICT portfolio.

Almost all government policy documents directed at education– green and white papers, and consultative material – involve ICT as a major constituent and/or delivery platform for ensuring educational success.

It is essential that members of a school's governing body are aware of the influences that ICT is having on the school development/improvement plan. This goes beyond ensuring value for money in computer hardware purchases and network installations. The main focus must be encouraging teaching and non-teaching staff to follow professional development courses to adopt, adapt and improve their use of ICT to help raise standards in their own subject areas. ICT can make a big contribution to the efficiency of school administrative procedures, including assessment, and to the school's leadership and management. The Government is encouraging schools

to consider their view of e-confidence, and governing bodies need an overview of local and national ICT developments in order to aid the school in deciding which parts of the e-confidence vision might support their drive to raise standards.

This guide will concentrate on how ICT can help with monitoring and assessment. It will indicate how you can use data to improve pupil performance, assess pupils' progress, explain differences

and your expectations of pupils and compare your school's national results, interpret changes and make comparisons, Use of such information can assist in determining how to drive up pupil attainment across the school.

Infrastructure

This guide will provide a review of school infrastructure, wider networking issues and an introduction to the range of ICT tools available. It will include advice on the procurement process, total cost of ownership (TCO) issues, network standards, broadband and technical support.

Using ICT to drive whole-school improvement

This guide will demonstrate that ICT has the potential to act as a catalyst in raising pupil motivation and improving pupil behaviour, in enhancing communication both within and between schools and in leading to improvements for teachers, school managers and parents.

Professional development

This will cover development for governors, headteachers and all school staff. As well as describing the opportunities for staff development across the school, it will suggest how ICT can help governors to be more effective and detail the training opportunities available.

Safety and protection

This will feature materials on internet safety and proficiency both for pupils and for staff. There will also be information and guidance on the legal implications for schools and governing bodies of data protection and copyright.
