It offers new opportunities to improve organisational performance, minimise pressure on teacher time and transform the learning experience for students by placing ICT improvement firmly at the heart of an institution, both in its operations and its development.

Becta has developed the self-review framework in collaboration with a

range of partners including Ofsted, the Qualifications and Curriculum Authority (QCA), the Training and Development Agency for Schools (TDA), the National College for School Leadership (NCSL), the National Strategies, the Specialist Schools and Academies Trust (SSAT), the Department for Education and Skills (DfES) and Naace. This is ensuring a coherent approach to ICT across the education sector that is set to position the UK as world leader in the use of new technologies.

Using the self-review framework, schools are able to identify where they are, and to plan the practical steps they can take to move forward. It offers schools a straightforward route to benchmark their ICT use against established best practice, and to develop clear strategies to ensure that their ICT infrastructure and systems meet their needs, not only now, but into the future.

Becta has also developed an accreditation scheme allowing schools the option of achieving external recognition of the progress they have made. Created in partnership with Naace, the ICT Mark enables schools and colleges to move forward in the knowledge that they are implementing recognised good practice.
